d. Financial Administrator's Report

We broke even in October. Revenue higher than budget. Expenses not up much. \$13,000 ahead of budge for the year. Continues to look good.

5. Cabinet Report

a. Education

The Confirmation Class has completed the study of the Apostle's Creed and Lord's Prayer.

The Confirmation Bell Choir will play in church on Sunday, December 10.

Sunday school averaged 14 children on Sundays. The lessons were Deborah, Joseph and his brothers, Joseph and his Family, and David and Goliath. The children also practiced songs for several weeks to sing in church. They did wonderful! The children also made new ornaments for Cross of Christ's Holidazzle Tree in the Park. The tree will be decorated this week.

Club 56 participants are presented with a theme each week where they read from the Bible and do an activity which helps them relate what they are reading and learning to their daily lives. The themes this month included turning sorrow into joy, fears, and beatitudes, and do not worry. The youth have also been bringing their favorite Christian songs to Club 56 so they can listen to peppy Christian music while doing our activities. The youth are also getting better with using their Bibles with this additional practice. One last note from Lisa Skifton: "They are such a kind, respectful, and delightful group of kids who bring such joy to my Wednesday evenings!"

The adult education classes will begin in January on the 2nd and 3rd Sundays during coffee hour. The plan is for these to be discussion sessions about religion. Once the topics are finalized for January further information will be published.

c. Finance

d. Personnel

Organists receive pay (\$80.79) on a per service basis. If there are two services the same day pay is \$121.21.

For contemporary services we recommend the accompanist receive the same pay as organist receives for a regular service.

For contemporary services Jacob does not want compensation. He considers his participation part of the singing group thus a volunteer position.

We recommend the choir director and choir accompanist receive the same pay. This is presently \$50 per service. They were on a yearly stipend but there has been less activity so, as Eileen and Jacob have requested, we recommend paying them on a per service basis.

For Lenten services we recommend paying the accompanist the same as organists if Lenten service is like a regular Sunday service. If using the Holden Evening Service, accompanist should receive same amount as when accompanying the choir as suggested by Eileen.

For directing bell choir, Eileen considers that a volunteer position and does want any pay.

Shelly receives \$80.79 when accompanying Pastor at Valley View.

Amount of pay for these positions is adjusted by the finance cabinet as part of the yearly budgeting process.

Regarding the Minnesota Sick and Safe

Time Law, the Personnel Cabinet recommends the following:

Option 1. Accrual and carryover:

Employees begin accruing ESST from their first day of employment;

ESST accrues at a rate of at least one hour for every 30 hours worked;

Employees are permitted to accrue a minimum of up to 48 hours of ESST in a year (more if the employer agrees to a higher amount); and

Employees carry over unused ESST into the next year. However, at no time can an employee's accrued ESST exceed 80 hours (unless the employer agrees to a higher amount)

Adding Option One is to be in addition to any benefits already being received by the employee.

Chuck Halverson a motion to approve adding recommendation by Personnel Committee and adding Option One, Jessica Brand seconded by motion carries unanimously.
