Attached are the financials for February. Similar to January, giving is below budget, but expenses are right on budget. Giving was \$3,803 below budget for the month. We finished with a deficit of \$3,405 vs. a budgeted surplus of \$1,000. For the year, we are about \$7,000 behind on budget. There were questions on the February snow removal billing. Motion was made by Chuck Halvorson to approve the finance report, seconded by Jessica Brand. Motion carried unanimously.

- 3. Added some extenders to the bulbs in the choir loft fixtures. Contacted Key Electric to see if this is to code. If not, will see what other options are available to us.

 - 5. Longer extenders will be coming this week for the choir loft.
